The right has been perfected under Permit 49877. The dates of priority are MARCH 13, 1986 FOR 0.013 CFS AND JUNE 2, 1986 FOR 0.076 CFS. The right is limited to not more than 0.089 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

of Brownsboro, State of Oregon, has made proof to the satisfaction of the STATE WATER BOARD of Oregon, of a right to the use of the waters of Little Butte Creek, a tributary of Rogue River

for the purpose of the irrigation of 85 acres of land under Permit No. 1200 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon and duly confirmed by order of the STATE WATER BOARD of Oregon, made and entered of record in the Record of Proceedings of said Board, at Salem, in Volume 1

This is to certify that I have examined APPLICATION 68686 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Richard K. and Darlene N. McCulloch of 290 South Fork Little Butte Creek Road, Eagle Point, Oregon, 97524, phone 826-7237, for the use of the waters of Little Butte Creek, a tributary of Rogue River, for the PURPOSE of irrigation of 10.0 acres,

that the PRIORITY OF THE RIGHT dates from March 13, 1986 for 0.013 cfs and June 2, 1986 for 0.112 cfs,



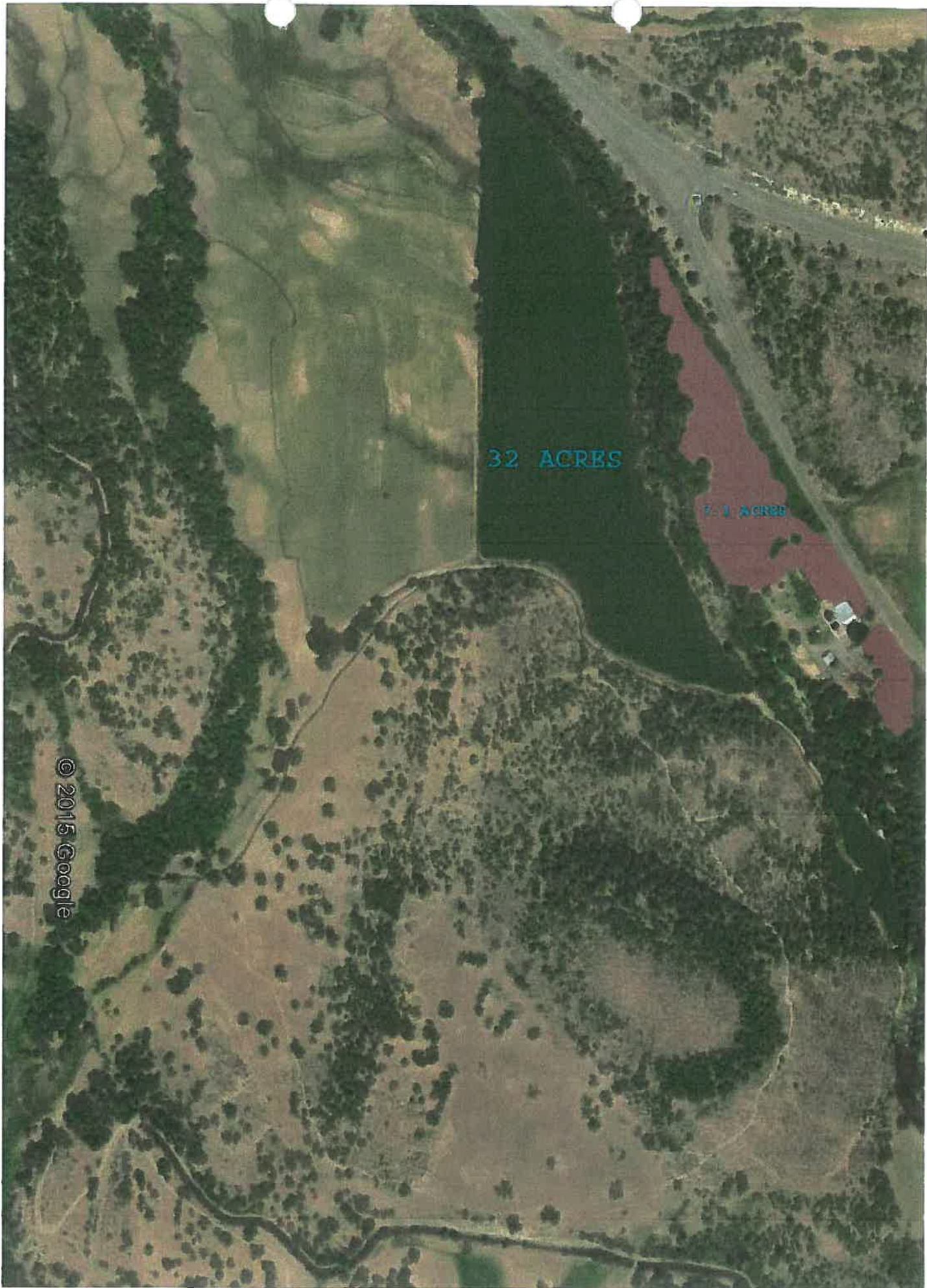
